This document is intended to assist Producers in understanding their minimum obligations when establishing a common collection system for single-use products, packaging and paper products designated materials (“**PPP Designated Materials**”) under the *Extended Producer Responsibility Regulation*, AR 194/2022 (the “**EPR Regulation**”).

Part 1 - Producers must provide the services outlined in Part 1 to all communities which are registered with Alberta Recycling Management Authority (“**ARMA**”). A Producer’s obligations to provide curbside recycling or depot recycling in a common collection system will depend upon the type of dwellings, the recycling services previously provided to said dwellings, and the date on which the community registers with ARMA.

Part 2 - Producers must meet the minimum service standards outlined in Part 2 for any curbside recycling or depot recycling services for PPP Designated Materials which a Producer provides in communities which are registered with ARMA.

For clarity:

- i. These standards are minimum standards. Producers may provide additional services if desired or necessary to achieve the Producer’s material management requirements under Section 19 of the EPR Regulation.
- ii. These service standards only apply to common collection systems for PPP Designated Materials. They do not apply to:
 - a. an alternative collection system for PPP Designated Materials, if applicable; or
 - b. hazardous and special products set as designated materials under the EPR Regulation.

Part 2A - Curbside Recycling Service Standards

Unless otherwise provided by ARMA, Producers must meet the following minimum service standards for curbside recycling of PPP Designated Materials in communities which are registered with ARMA.

1. Frequency

- Single-family Dwellings: Producers must provide curbside collection at least every 2 weeks.
- Multiple-family Dwellings: Producers must provide collection at an appropriate frequency, considering the available receptacles and storage space.

2. Receptables— Producers must:

- Provide receptacles in collection operations where reusable receptacles are used prior to commencing curbside collection;
- Provide adequate receptacles for storage reflecting the collection frequency; and
- Repair or replace receptacles which are damaged due to age or during collection, within one week of the Producer, PRO, or service provider receiving a request to repair or replace the damaged receptable. Recurring receptacle repair or replacement incidents may result in an investigation and service fees.

3. PPP Designated Material - Producers providing curbside recycling must accept:

- All PPP Designated Materials; or
- All PPP Designated Materials which are not accepted by depot recycling, if a Producer is providing both curbside recycling and depot recycling in the common collection system. For clarity:
 - i. All PPP Designated Materials must be accepted in the common collection system;
 - ii. A Producer must have a uniform province-wide approach to which PPP Designated Materials are accepted through curbside recycling and which PPP Designated Materials are accepted through depot recycling, and
 - iii. ARMA may require a Producer to provide curbside collection for all PPP Designated Materials, regardless of depot recycling, if a Producer does not meet its material management requirements established under the EPR Regulation.

Part 2B - Depot Recycling Service Standards

Unless otherwise provided by ARMA, Producers must meet the following minimum service standards for depot recycling of PPP Designated Materials in communities which are registered with ARMA.

1. **Hours of Operation** – Producers must ensure depots operate for at least:
 - The same amount of hours as staffed depots operating in the community prior to November 30, 2022; or
 - The same amount of hours for staffed waste drop off locations within the community or, if not applicable, within a comparable community.
2. **Depot Locations** – Producers must provide at least as many depot locations as waste collection drop off locations.
3. **Receptacles** – Producers must:
 - Provide and maintain adequate receptacles prior to commencing depot recycling; and
 - Collect and replace, and/or empty receptacles at an adequate frequency.
4. **PPP Designated Material** – Producers providing only depot recycling must accept all PPP Designated Materials.
